Terms and Conditions

"You" means the person who has loaned the Equipment from Nikon and signed this rental agreement ("Agreement") on the preceding page.

"Nikon" means Nikon Singapore Pte. Ltd.

This Agreement is made between you and Nikon. Your loan of the Equipment set out on the preceding page is subject to the following terms and conditions:

- 1. <u>Rental Fee.</u> You agree to pay the Rental Fees for the corresponding product ("Equipment") to Nikon in the manner as set forth in the Annex A as attached hereto. Unless otherwise agreed, the Rental Fees shall be immediately payable upon collection of the Equipment at Nikon Experience Hub, Funan, Singapore.
- 2. <u>Renter Eligibility.</u> Only Singaporeans, Singapore Permanent Residents who are above 18 years old are eligible to enter this Agreement. For students who are below 18 years old, a parent / legal guardian has to be present at point of collection, including loaning the Equipment and signing the Agreement on behalf of the student. You are restricted to the rental of one (1) piece of the Equipment only. You shall not rent the same Equipment within the same month, and there shall be at least five (5) days apart from the last rental. Upon renting and collection of the Equipment, you must present valid photo identification and proof of residency status in Singapore (such as bank statement or utility bill) for verification. At all times, Nikon has the sole and absolute discretion to decline the rental of the Equipment.
- 3. <u>Rental Period.</u> The standard rental period is five (5) days (including the dates of both collection & return) ("Rental Period") unless Nikon expressly agrees in writing otherwise. The Rental Period shall commence on the date the Equipment is collected (as indicated on the preceding page) and may be reduced or extended at Nikon's election in its sole and absolute discretion.
- 4. <u>Time and Place of Collection / Return.</u> The Equipment shall be collected and returned from Monday to Sunday between 11:00 am to 8:00 pm. The Equipment shall be collected and/or returned in person at Nikon Experience Hub, Funan, Singapore.
- 5. <u>Inspection and Use.</u> Upon collection of the Equipment, you agree to inspect the Equipment and report to Nikon any and all defects, damage or malfunctions in the Equipment at that time. You are wholly responsible for proper and careful use of the Equipment and keeping the Equipment in the same condition throughout, and shall not remove, modify or alter or permit the removal, modification or alteration of any part of the Equipment, including markings indicating Nikon's ownership of the Equipment. You shall not use the Equipment for any unlawful purpose.
- 6. <u>Title.</u> The Equipment shall at all times remain the sole and exclusive property of Nikon and you shall have no right, title or interest in or to the Equipment, save for the right to temporarily possess and use of the Equipment subject to the terms and conditions of this Agreement. You shall not do or permit to be done any act which may jeopardize Nikon's right, title or interest in the Equipment and shall give immediate written notice to Nikon in the event of any malfunction, loss, accident or damage to the Equipment.
- 7. <u>Date of Return.</u> You shall return the Equipment in person on or before the Return Date specified on the preceding page. If the Equipment is not returned on or before the Return Date, you agree that Nikon shall be entitled to charge / invoice you additional fees at the rates set forth in Annex A as attached hereto. If you and/or the Equipment cannot be contacted or located (as the case may be), Nikon shall seek all other legal remedies in respect of its loss.

- 8. <u>Condition after Return.</u> Upon return, you will be wholly responsible for ensuring that the Equipment (including, but not limited to, lens hood, front or/and rear lens caps, and original packaging as collected) shall be in the same condition as it was when collected. Nikon will assess the condition of the Equipment and reserves its right to charge / invoice you for any malfunction, loss, accident or damage (other than those discovered during the inspection in paragraph 5 above). If the Equipment is beyond repair, you will be deemed to have purchased the Equipment at its full retail price. Acceptance by Nikon of the return of the Equipment does not waive any claim Nikon may have against you for patent, latent or hidden damage caused to the Equipment.
- 9. <u>Indemnity.</u> You agree to indemnify and hold harmless Nikon from any and all claims, liabilities, damages, costs or loss arising from or relating to injury, theft, loss, damage and/or destruction of the Equipment or to persons or property or personal data arising from or relating to your use, misuse, maintenance, storage or transport of the Equipment during the Rental Period, including but not limited to:
 - a. claims, liabilities, damages, costs or loss arising from claims asserted by any third parties and/or regulatory authorities in connection with or relating to the Equipment; and
 - b. costs for any repair or replacement of the Equipment, and any labor, material and/or shipping costs in connection with such repair or replacement.
- 10. <u>Exclusion of Warranties and Liability.</u> You acknowledge that all Equipment rented will be at your sole discretion and election as to what you require. No warranties, guarantees or representations are made by Nikon, its agents or representatives of any form or nature in respect of the performance of the Equipment. Nikon shall not be responsible or liable to you or third parties for any damage, including loss of profits or other special or consequential damage arising out of the use, malfunction or inability to use any Equipment.
- 11. <u>Governing Law and Jurisdiction</u>. This Agreement shall be governed by and construed in accordance with the laws of Singapore, and you agree to submit to the exclusive jurisdiction of the Courts of Singapore.
